

- ICESCR: right to food





# Land market control

#### SAFER is a public agency for market land control:

#### Its powers are:

- Stopping land transaction
- Pre-emptive rights to land
- Since 2023, intervention in transfers agricultural companies shares:

#### Its objectives are:

- Provisioning of land for new entrants
- Preventing land concentration
- Consolidating small holdings in viable units





# **Reshaping property law**

#### **Highest rate of land concentration:**

• In 2013, 430 people owned 50% of land

#### Land Reform Acts (2003 - 2016)

- Community pre-emptive right to buy land in a willing seller willing buyer situation
- Community right to buy «neglected or abandoned» land from an unwilling seller
- Community right to buy land for «sustainable development» project from an unwilling seller


#### **Scottish Land Fund**

• 1 million grant to buy land





# Land reforms



#### Proposal EU Directive on Agricultural Land (ECVC 2023)


- Define land as a common
- Set up measures to fight land grabbing (art.3)
- Create a European land observatory (art.4)
- Stronger land market regulation (art.6)
- Plans to improve soil health (art.14)
- Promote agro-ecological land uses (art.18)
- Set up public land banks (art.21)

#### From land to agrarian reform: from CAP to CAFP

- Access to land
- Democratic control
- Farmers autonomy
- Market access and fair remuneration
